- Ability to self-direct, interact, and adapt effectively in complex, dynamic situations;
- Ability to communicate and collaborate with patients and families about health findings, diagnosis, treatment, self-care, and prognosis in a holistic and compassionate manner;
- Excellent interpersonal skills and demonstrated ability to communicate effectively and build relationships with other health professionals and disciplines using a variety of communication strategies;
- Demonstrated ability to transfer knowledge, teach, coach, and mentor others; ability to implement and evaluate planned change;
- Ability to critically assess and evaluate health research literature to determine best practices;
- Ability to introduce education and evidence based research into practice areas;
